### INDEPENDENT AUDITOR'S REPORT

#### TO THE MEMBERS OF INTERNATIONAL BAMBOO ASSOCIATION

#### Report on the audit of the Financial Statements

We have audited the financial statements of **INTERNATIONAL BAMBOO ASSOCIATION** ('the Company'), which comprise the Balance Sheet as at 31 March, 2022, the statement of Profit and Loss and statement of cash flow for the year ended, and notes to the financial statement, including a summary of significant accounting policies and other explanatory information.

Instead of the above factors there is no uncertainty on the company's ability to continue as a going concern. The company has prepared its financial statements on going concern basis.

#### Information other than the financial statements and Auditors' Report thereon

The company's management and Board of Directors are responsible for the other information. The other information compromises the information included in the company's annual report, but does not include the financial statements and our auditors' report thereon.

Our opinion on the financial statement does not cover the other information and we do not express any form of assurance conclusion thereon.
